SUBJECT: Verizon Telephone and DSL Ordering Procedure for the Honda Grand Prix

I will be the on-site contact for your orders to our local telephone company, Verizon. I have created an order form for you to use. It is important that you keep me in the loop so when the technician arrives I will be aware of the service you have ordered. **Be sure you copy me on all orders.** The order form is on the next page with all the contact information.

Verizon Single Business line pricing is as follows and does not include taxes:

Monthly - \$45.00 (per single line) \$ 51.99 (per rotating line – minimum of 2 lines)

Installation – Initial Ordering Charge - \$33.90; Line Connection Charge - \$35.00 (per line)

Verizon DSL Ordering Procedure has changed from last year. Instead of calling a toll-free number to order the DSL service, you can request the service using the order form on the next page and sending it to the email contacts noted at the top of the form. You can order the telephone line and DSL at the same time now. Previous years you had to order the phone line first and wait for the 10-digit number assignment before ordering the DSL. This same order form is also used for Dry Loop DSL.

Verizon DSL Pricing: Ship modems to: City of St. Petersburg Radio Shop, Attn: Kim Schoos at 551 19th Street North, St. Petersburg, Florida 33713. **I will deliver the modem to you when you get on-site to setup.** Pricing below is for Dynamic and Static addressing. Notice rates are the same between DSL with Phone Line and Dry Loop. With DSL with Phone Line you will have the additional cost of the phone line since you will be able to use it for voice and/or data. Dry Loop is data only use.

30 Day Minimum Charge, Activation & Wireless Router = One time charge of \$379.99

30 Day Minimum Charge, Activation without Wireless Router = One time charge of \$280.00
